2017 END OF SESSION REPORT



Help for Elderly and Disabled Preserved by General Assembly

In the waning days of this year's session, it appeared state lawmakers would roll back vital in-home care services for elderly and disabled Missourians. But with only minutes remaining, legislators passed legislation that preserves funding for in-home and long-term care for the elderly and disabled while keeping in place an existing tax credit for low-income renters.

As introduced, HCB 3 had pitted the interests of elderly and disabled needing medical care against those of low-income renters who are also elderly and/or disabled and eligible for a tax credit. The credit averages \$535 a year and helps people to meet the costs of basic necessities.

As originally passed by the Missouri House, HCB 3 repealed the renters' tax credit and used the savings to maintain funding for the in-home and long-term care program. Supporters of the House version of the legislation said that repealing the renters' credit was necessary to save funding for some 8,000 elderly and disabled who rely on in-home services to stay out of nursing homes.

But repealing the renters' credit would have cut off assistance to over 100,000 needy Missourians. The Missouri Catholic Conference (MCC) argued that the bill as passed by the House presented a false choice between the two needy groups. The MCC urged legislators to find other ways to fund the care for the elderly and disabled while keeping in place the renters' tax credit.

After the House passed a repeal of the renters' credit, the Senate amended HCB 3 by

removing the proposed repeal and funding the in-home care by sweeping funds from the unexpended balances of various state programs. Senator Kiki Curls (D-Kansas City) offered the Senate amendment.

On the last day of the session, the House accepted the Senate amendments and passed HCB 3. The bill now must be signed by Governor Greitens in order to become state law

The bill only offers a one-year fix. The fund sweep cannot be repeated next year, so legislators will have to find a

new source of funding in order to maintain the in-home care services for the elderly and disabled. The year-long reprieve should offer an opportunity for lawmakers to evaluate all of Missouri many tax credits. The MCC told legislators that the renters' credit could use improvements, but so could the other existing tax credits. Tax credit reform looks to be a priority for the 2018 session of the Missouri General Assembly.

General Assembly Funds Pro-life Programs, Defunds Planned Parenthood, But Fails to Pass Pro-life Legislation

The 2017 legislative session ended with both pro-life victories and pro-life defeats. The General Assembly provided generous funding for pro-life programs, including \$6.4 million for the Alternatives to Abortion (ATA) program. The ATA program provides funding for pregnancy resource centers and maternity homes that offer women who are facing a crisis pregnancy material and spiritual assistance with their pregnancies, as well as educational opportunities to help them thrive in their role as mothers.

A program aimed at supporting fathers also received funding in the amount of \$1.5 million. This program, called the Fatherhood Initiative, seeks to encourage the participation of men in the lives of their children, with the ultimate goal of pulling at-risk children out of poverty.

The General Assembly also appropriated \$13 million for the Show-Me Healthy Babies program, which offers medical care to unborn children whose mothers are uninsured. This program is designed to provide prenatal care for the unborn, so that they achieve a healthy birth weight and have every opportunity to succeed.

Using the budget process, the legislature also cut off family planning funding to organizations that perform abortions or provide counsel for abortions. This is the second year in a row the Missouri General Assembly has defunded Planned Parenthood through the budget process.

The legislature failed, however, to pass two priority pieces of pro-life legislation the MCC worked hard to get passed.

HB 174 and SB 41 were bills that would have pre-empted the recently enacted St. Louis City ordinance that made St. Louis an abortion "sanctuary" city. HB 174 passed the House and made it to the Senate calendar, but never made it to the Senate floor for further debate. A Senate version of HB 174 (SB 41) was debated on the Senate floor late one evening and into the early hours of the next morning earlier in the session, but it was never called back up from the Senate calendar for further debate and passage. As a result, the St. Louis abortion sanctuary ordinance is still in effect.

The Senate also failed to act on HB 194 and SB 67, bills that would ensure that fetal tissue from abortions in Missouri isn't diverted for research and other purposes, and that abortion clinics are inspected annually. HB 194 came over to the Senate late in the session and never made it out of committee. SB 67 was debated earlier in the session, but was ultimately never passed in the Senate, despite an extended debate.

On May 22, 2017, the Archdiocese of St. Louis, Our Lady's Inn (a local maternity home), and O'Brien Industries sued the city of St. Louis challenging the abortion sanctuary ordinance. Archbishop Carlson stated at a press conference announcing the lawsuit that the passage of the ordinance is, "a marker of our city's embrace of the culture of death." 2017 End of Session Report

Bills reported as "Truly Agreed to and Finally Passed," have been approved by the Missouri General Assembly and await action by the governor. The governor has until July 15, 2017 to sign or veto bills.

"Raise the Age" Fails in Legislature

Raise the Age is an effort to increase the age from 17 to 18 of juvenile jurisdiction. Currently, Missouri is one of only seven states that still charge 17-year-olds in adult court. The vast majority of these teens commit non-violent offenses; those that do commit serious crimes would still be charged in adult court.

This session, there were two bills dealing with Raise the Age: SB 40, sponsored by Senator Bob Dixon (R-Springfield), and HB 274, sponsored by Representative Nick Schroer (R-O'Fallon). First up with a hearing was SB 40, where a large group of people was called to testify—mostly in favor of the bill. They testified that youth could be rehabilitated and there was no need to house them in adult jails where they could be vulnerable to physical and sexual abuse. The Juvenile Justice Association opposed the bill because they didn't know if they would have the resources to house the youth. The bill languished in the Senate committee, ending with no vote on the bill.

HB 274 then had a hearing in the House. This time Rep. Schroer was ready to address the cost issue. He told the committee that the cost was misleading because youth would have to be taken in either by the adult court or the juvenile court. The Juvenile Justice Association again testified to the cost issue. Eventually, the bill was voted "Do Pass" by a vote of 10-1.

By that point there was about a month left in the session and Rep. Schroer was afraid that the bill would never make it through the House in time. He went in search of a Senate bill to which he could add the language as an amendment. He found one in SB 50, a health care directive bill.

Pitching the "Raise the Age" proposal as a way to prevent suicide (youth held in adult jails are 36 times more likely to commit suicide than youth in juvenile

detention facilities), the House added an amendment to SB 50. When SB 50 came back to the Senate, Senator Gina Walsh (D-St. Louis) called for a conference committee to iron out the differences in the bill. The conference committee kept only a handful of amendments—and the Raise the Age language was not included. We thank Rep. Schoer for his tenacity in trying to get the bill passed.

Raise the Age was supported by many groups, including the Missouri Catholic Conference. The MCC supports the bill because young people should not be placed in adult jails and treated like adults in criminal proceedings. This issue is expected to be re-visited next session.

Drug Registry Bill Fails to Pass - Again

As they have in past sessions, state legislators spent days debating how to stop patients from "doctor shopping" for painkillers and other prescription medications to satisfy their drug addiction, but in the end they failed to pass any bill.

State Representative Holly Rehder (R-Sikeston) has been the tireless champion for creating a program that would allow doctors and pharmacists to check a state registry to see if a patient was abusing a prescription drug. Missouri is the only state without such a program.

This year Rehder's bill was HB 90; it passed the House with overwhelming support. The Senate, however, undercut the effectiveness of the drug monitoring program by adding several crippling amendments. One amendment, for example, purged a patient's drug history after 180 days. In the end the two chambers could not reconcile their differences and the legislation died.

The MCC supported HB 90 as a way to combat doctor shopping. The proposal included provisions to protect confidentiality by barring disclosure of a patient's drug history except to doctors, pharmacists and law enforcement authorities.
